#### Welcome

The Co-Chair of Philanthropy Australia (PA), Ann Johnson, opened the meeting, welcomed attendees and acknowledged the traditional custodians and caretakers of the waters and the land on which the attendees were gathered, noting she was on the land of the Gadigal people of the Eora nation. She paid her respects to their elders both past and present and extended this respect to any Aboriginal and Torres Strait Islanders who were in attendance.

## **Ordinary Business**

### 4. 2021 AGM Minutes

The Chair began by moving that the minutes of the 2021 AGM, distributed with the Notice of Meeting, be accepted as a true and correct record of the 2021 AGM.

**RESOLUTION:** The meeting accepted the minutes of Philanthropy Australia's 2021 Annual General Meeting, held on 19 May 2021.

### 5. 2021 Annual Report

Amanda Miller, Co-Chair, presented the Annual Report 2021 and highlighted the following:

Despite the profound challenges presented by the ongoing COVID-19 pandemic, achievements
including the launch of our Blueprint to Grow Structured Giving and our Strategic Plan for 2022-25,
harmonise Philanthropy Australia's priority to double structured giving in Australia by 2030, and set
out a bold agenda for the organisation's growth, a significant shift in PA's membership goals through
a broader engagement focus and a larger investment from key supporters to help us achieve our longterm aims.

- We ran a stimulating and popular webinar series on promoting better philanthropy. Our conference, which featured international figures from US and Asian philanthropy, provided a benchmark for debate within the sector about fundamental issues of diversity and power. The Australian Philanthropy Awards were presented as an online event that celebrated some of the best examples of innovative and bold philanthropy. At the end of the year, we launched our Reconciliation Action Plan following a number of initiatives in recent years to support funding of First Nations' organisations and projects.
- The pivot to online events, including conference related workshops and webinars, showed there was a healthy appetite for content that supported the sector with new ideas, strategies, and big thinking. Philanthropy Australia has led the way in helping to shape some of these approaches, especially the Pay What It Takes initiative.
- Philanthropy Australia has been active in the political sphere, launching our Federal election statement that reflected the increased engagement with Government and Opposition. We also built strong links with the Federal Treasury and Ministerial Advisers as we secured engagements for our Philanthropy Champions with the Assistant Treasurer the Hon Michael Sukkar MP, as well as the Shadow Minister for Treasury and Charities the Hon Andrew Leigh MP.
- In a challenging political environment, we helped marshal a coalition of over 100 philanthropic entities and individual philanthropists who successfully lobbied to ensure the proposed ACNC Governance Standards 3 regulation that would have threatened charities' free speech and introduce unnecessary red tape did not become legislation. The value of this increased engagement with Canberra was evident in the 2022 Federal Budget which contained a historic reform that will enable 28 community foundations to receive a specific listing as Deductible Gift Recipients.
- PA is committed to developing a stronger value proposition for our members tailored to people's needs and interests to drive our membership growth. Internally, we are investing in our systems, processes and people to support this growth.
- All this could not happen without strong support from many of Australia's leading foundations and very generous individual donors who share our vision for a more giving nation. PA thanks everyone who is on this journey with us our Board, our staff, our funding partners and our members.

Ms Miller passed the chair back to Ms Johnson who opened the meeting to the floor for questions.

There were no questions from the members.

## 6. Annual Financial Report – Audited reports for the year ended 31 December 2021

Caroline Stewart, Chair of the Finance, Audit, Risk and Compliance Committee (the FARCC Chair) presented the audited financial report. She noted the Financial Statements have been subjected to audit with an unqualified opinion issued by PA's auditors Saward Dawson.

The FARCC Chair presented the key contributors to PA's financial performance as follows:

• PA had a reported a financial deficit of \$280,554 in the 2021 financial year in comparison to a surplus of \$691,599 in 2020. This includes an unrestricted surplus from operations of \$123,888 and a deficit of (\$404,442) from restricted activities – that is where funds received and payments made relate to specific or tied purposes such as PA Chapter groups, other partnerships and grants for specific

projects. The deficit this financial year is as a result of funds being expended during the financial year that were received in prior years. In 2020 there was a surplus of \$345,682 from restricted activities.

#### Profit and Loss:

- o Income totalled \$5,048,332, a reduction of 27% due to a decrease in collaborative activity and JobKeeper payments.
- Membership numbers and fees remained steady
- o Pleasingly, grants, donations and sponsorships were over \$1 million.
- Our Philanthropy Champions continued their support of the Philanthropy Champions Program, with
  over 20 philanthropic leaders supporting Philanthropy Australia for up to three-year periods.
   Philanthropy Champions' support has underpinned the transition to a new business model which was
  fully implemented in 2018, whilst also supporting our policy and advocacy initiatives to advance
  philanthropy in Australia.

## Expenses:

On the expense side there was a continued strong and disciplined focus on managing our expenses and expenditure was lower than budgeted.

 Expenses totalled \$5,328,8856 and was under budget due to delayed expenditure on projects such as the new website, staff vacancies and minimal staff travel.

### • Balance Sheet

Our balance sheet position as at 31 December 2021 continued to be strong, with net assets of \$2.3m and over \$3 million in cash or term deposits accounts.

On the liability side, the most material liability is associated with income received in advance (where we can defer such revenue under accounting standards), for both memberships and grants. This represents \$1 million.

- The FARCC Chair thanked the PA finance team for doing an excellent job with limited time
  and resources. The Chair noted particular appreciation for Dinah Rowe Roberts, Executive
  Director-Business Services, as she transitioned into her full-time role managing PA's finances
  and managed the ongoing enhancement of PA's financial reporting processes and controls.
- The FARCC Chair also thanked the other members of the Finance, Audit, Risk and Compliance Committee, including Co-Chair Alecia Rathbone, for their support, knowledge and expertise during the past year.

There were no questions from the members.

Tuesday, 15 March 2022. The voting process was managed by our Returning Officer, Gavin Ryan of OGL Group.

2022 Annual General Meeting and declared the event closed at 3.27pm.
